Bilt x Equinox Member Benefits Terms and Conditions

These Equinox x Bilt Member Benefits Terms and Conditions (“**Terms**”) govern your participation in the Equinox x Bilt member benefits program (the “**Program**”) offered by Bilt Technologies, Inc. (“**Bilt**”) in collaboration with Equinox Holdings, Inc., together with its affiliates (“**Equinox**”). The Program provides certain benefits to eligible members of the Bilt Rewards program (each, a “**Member**”) in connection with an active Equinox membership. Your participation in the Program is expressly conditioned upon your acceptance of these Terms. By linking your Bilt account with your Equinox account or otherwise accessing or using any Program benefits, you accept these Terms and enter into a legal agreement with Bilt. You should read these Terms carefully. If you do not agree to these Terms, you may not participate in the Program. These Terms supplement, and do not replace, the [Bilt Rewards Terms & Conditions](#) (the “**General Terms**”) and the Equinox membership agreement, club rules, and policies, each of which continue to apply. In the event of a conflict, the applicable governing agreement will control. 1. Eligibility and Account Linking. Members with Bilt and Equinox accounts in good standing are eligible to participate in the Program. To participate in the Program and redeem Credits or other Program benefits, Members must link their Bilt and Equinox accounts. If the same email address is associated with both accounts, the Member will receive an account linking request in their Equinox account that must be accepted to complete the linking process. If different email addresses are associated with the Member’s accounts, the Member must initiate the linking process through the Equinox platform or Bilt platform. Program benefits are available only at participating Equinox locations and are subject to change and availability.

2. Promotional and Offers. We may offer promotions or curated offers in connection with the Program. Any promotions or offers will be denoted accordingly on the Bilt platform and will be subject to additional terms and conditions. Other restrictions may apply. Certain introductory or promotional terms (including complimentary services and bonus offers) may be time-limited and subject to modification or termination by Bilt at any time.

Beginning on August 19th, 2026 and continuing until terminated by Bilt in its sole discretion (the “**Promotional Period**”), Members with Bilt and Equinox accounts in good standing who (i) enroll in an Equinox membership through the Bilt platform and (ii) link their Equinox and Bilt accounts will be eligible to receive one of the following one-time promotional benefits, as selected by the Member: (a) 10,000 Bilt Points, (b) a complimentary 50-minute Equinox Spa session, or (c) a complimentary 1-hour Equinox Personal Training session. The complimentary Equinox Spa session excludes Equinox Hudson Yards, Equinox West 92nd Street, and Equinox Rainier Square. Sports Club Spa sessions are redeemable solely at eligible Equinox Sports Club locations, and standard Spa sessions are redeemable solely at non-Sports Club Equinox locations.
